- ❖ All contest deadlines will be 14 days prior to the day of the audition.
- ❖ The late and final online entry deadline will be seven days prior to the day of the audition.
- ❖ Correction to an existing student entry may be made between 13 and seven days prior to the contest without penalty, but a student entry added less than 14 but more than seven days prior to the contest will result in an additional 100% student late fee.
- ❖ Entries begun less than 14, but more than seven days prior to the contest, will be assessed a 50% additional campus fee charge and 100% student fee charge.
- ❖ A campus entry created less than fourteen days prior to the contest will be subject to the TMEA Grievance Process. Directors will be allowed to add or change student entries the day of the audition. The 50% additional campus and 100% additional student late fees will be assessed.
- ❖ All fees must be paid or supported by a school purchase order prior to the start of an audition.
